

**City of Loveland Parks and Recreation Department  
Use Regulations for Privately Owned Golf Carts at  
Mariana Butte Golf Course**

1. Privately owned golf carts ("cart") may be operated on the Mariana Butte Golf Course only when in compliance with these regulations.
2. Each cart shall have a current and a valid registration displayed on the front-left portion of the cart. Fifty (50) private cart permits are allowed per year. Only private cart owners previously registered and for which such registration is renewed on-or-before January 31, of each year may be re-registered, all new permit holders, to the limit of 50, must register and pay in full by January 31 of each year.
3. Registration is not transferable from one owner to another.
4. Carts may be operated only by the owner, as of January 1, 1989, and by authorized persons listed on the application for registration, each of who shall be a spouse or child or parent over the age of 16 years and in possession of a valid driver's license.
5. Each application for registration shall be accompanied by a certificate of insurance (use City form attached) showing liability coverage for the owner and all authorized operators. Coverage to include bodily injury and property damage in an amount not less than \$150,000 per claimant, \$500,000 per occurrence. Expiration or cancellation of such insurance, or reduction of limits to less than those required, shall suspend the registration until renewed or replaced.
6. All carts must be operated in accordance with the rules for operation of golf carts of the Mariana Butte golf course.
7. Annual registration fees, subject to change, are as follows:
  - a. For a cart under the ownership of one person or jointly owned with a spouse, dependent child or dependent parent residing with such person:  
**YEARLY PERMIT:** as of January 1, 2010, \$ 750.00
  - b. For a cart under the ownership of one person or jointly owned with a spouse, dependent child or dependent parent residing with such person:  
**PER USE BASIS** as of January 1, 2010, \$10 for 9-holes and \$15 for 18-holes
8. Cart registrations may be revoked or suspended for a specific period of time as a consequence of violating any of the regulations pertaining to the use of the cart, at the discretion of the Golf Course or Parks and Recreation Department management. No refund shall be made for any portion of the registration fee in the event of such revocation or suspension. Revocation of a registration may be permanent, and the registration may not thereafter be renewed.
9. Private cart use by anyone other than authorized operators listed in the application for permit will not be allowed unless accompanied by a listed authorized operator. Suspension and revocation regulations are applicable.

## APPLICATION FOR PRIVATE GOLF CART REGISTRATION

I hereby apply for a 20\_\_\_\_\_privately owned golf cart registration for the golf cart described below and attached. I have read, understand and agree to the rules for the operation of golf carts and the regulations for privately owned golf cart usage at the Mariana Butte golf course. My privilege of using a private cart at the golf courses is valid only so long as I obtain a registration for 2010 and each consecutive year thereafter. Registration may not be transferred to another person and it may not be renewed if I should fail to complete an application and register my golf cart prior to January 31 of each year. Listed below are additional authorized operators, all of whom possess valid driver's licenses and are related to me either as spouse, child, or parent.

***In consideration of registration and use of my golf cart at the identified City Golf Courses, I, for myself, my personal representatives, my heirs, and each of the children under 18 years of age listed below, hereby:***

1. ***Agree to defend, indemnify and hold the City of Loveland, its officers and employees, insurers and self-insurance pool, if any, harmless from any and all liability claims and demands including but not limited to claims arising from property loss or damage, bodily injury, personal injury, death, or any other loss of any kind whatsoever, arising out of or in any manner connected with, in whole or in part, the presence and use of my golf cart by myself and all other persons at the Mariana Butte golf course; and***
2. ***Assume the risk of and waive all claims against the City of Loveland, its officers and employees, for any and all personal injuries, including but not limited to claims arising from property loss or damage, bodily injury, personal injury, death or any other loss of any kind whatsoever, arising out of or in any manner connected with, in whole or in part, the presence and use of my golf cart by myself and all other persons at Mariana Butte golf course.***

***Further, by signature below my spouse, child(ren) age 18 or older, or parent agrees to the foregoing indemnity and waiver of claims***
